RONALD MCDONALD HOUSE IN MADISON, WISCONSIN. THE HOUSE IS LOCATED
WITHIN WALKING DISTANCE OF THE AMERICAN FAMILY CHILDREN'S HOSPITAL AND
A FREE SHUTTLE SERVICE, OPERATED WITH VOLUNTEER DRIVERS, IS PROVIDED TO
AND FROM ALL MADISON AREA HOSPITALS AND AFFILIATED CLINICS. THE
FAMILIES OF SERIOUSLY ILL CHILDREN MAY STAY IN THE HOUSE FOR A FEE.
THERE IS A SUGGESTED DONATION OF \$10 PER NIGHT THAT IS WAIVED IF THE
FAMILY CANNOT AFFORD IT. IN ADDITION TO A ROOM, THE FAMILIES ARE
PROVIDED FOOD, LAUNDRY FACILITIES, AND ALL THE COMFORTS OF HOME. THE
HOUSE IS STAFFED 24 HOURS PER DAY AND OPERATES 365 DAYS A YEAR UNDER
THE MANAGEMENT OF A SMALL FULL-TIME STAFF, A PART-TIME STAFF OF TEN,
AND 180 VOLUNTEERS. IN 2013, OVER 1,200 FAMILIES WERE GUESTS OF THE

THE ORGANIZATION PROVIDES FREE DENTAL AND MEDICAL SERVICES TO CHILDREN

FIVE COUNTIES IN NORTHERN ILLINOIS. SINCE ITS INCEPTION, THE CARE
MOBILE HAS HELPED MORE THAN 19,000 CHILDREN PROVIDING SERVICES WORTH IN
