WITHIN WALKING DISTANCE OF THE AMERICAN FAMILY CHILDREN'S HOSPITAL AND
A FREE SHUTTLE SERVICE, OPERATED WITH VOLUNTEER DRIVERS, IS PROVIDED TO
AND FROM ALL MADISON AREA HOSPITALS AND AFFILIATED CLINICS. THE
FAMILIES OF CHILDREN MAY STAY IN THE HOUSE. THERE IS A SUGGESTED
DONATION OF \$10 PER NIGHT THAT IS WAIVED IF THE FAMILY CANNOT AFFORD
